# Did you not get any or not enough royalties with a payout?

Submitting your claims to us is really simple via the Online Portal: **www.gema.de/portal.** To do this, please select *Services* in the menu on the left, click on the *Claims* tile and then you can get started straight away.



- There, we will ask you step by step for the most important information regarding your claim.
- If we have all the details in one place, we can look into your matter swiftly.
- On the GEMA Online Portal, there are other relevant services regarding your data, works and royalties.
  - By using the service *Work declaration*, you can easily register your works with us.
  - Our service *My royalties* provides you with a graphic analysis of your turnover and usage figures.

**Do you not have a user account yet?** No problem: Just click on "not registered yet" below the login box and **create it in just a few steps.** After that, you can get started straight away.

## Important tips before you submit your claim

#### Have you registered your work with us?

In order to pay out your royalties, we need to know your works. Please always register them directly - even before they are played in public. Two pieces of information are particularly useful in this context:

- The performer
- The "International Standard Recording Code" (ISRC) if your music is played online

#### Was your work played on Spotify, YouTube, iTunes or similar services?

In order to find out how, when and by whom your royalties are paid through, it is important which country your music was played in. The following differentiation is important:

1. Was your work played in Europe or within the remit of the association International-Copyright-Enterprise (ICE)?

In that case, you receive your royalties directly via us, that is in the following categories:

- Music on Demand Streaming (MOD S, MOD S VR)
- Music on Demand Download (MOD D, MOD D VR)
- Streaming on mixed online platforms (GOP, GOP VR)

#### When do you get your royalties?

#### 2. Your work was played outside of Europe or outside of the remit of ICE?

In that case, you will also get your r**oyalties paid via ourselves, but only at a later date** and in these categories:

- International income distribution performing rights (A)
- International income distribution mechanical rights (A VR)

#### When do you get your royalties? Why later?

The collective management organisations in the countries calculate the royalties in accordance with their own distribution rules and we pay them to you once they have done so as their contractual partner. This process is a bit more complex and therefore takes longer.

**What is ICE?** ICE is a large music licensing platform. We founded it, together with two other European collective management organisations so that we can pay your royalties to you more quickly when your music is played online.
