## 2024 GENERAL ASSEMBLY MEETING

## **NOTES:**

- The elections of the delegates and alternates will be decided by a majority of votes of the members present or by live online voting at the beginning of the hybrid meetings of the associate members of the three professional categories on 14 May 2024.
- Please submit your declaration to stand as a candidate
  - by 2 May 2024 if you wish to be introduced by a short written profile in advance (see below).
  - by 10 May 2024 or at the meeting if you do not wish to be introduced by a short written profile in advance.
- The candidate or the associate publisher member he or she represents must have been a GEMA member for at least two years and must have earned a total amount of royalties of at least EUR 50.00 in the two calendar years preceding the year of the election. Furthermore, it should be noted that members authorised to represent a full publisher member cannot be elected as delegate or alternate at the same time.
- The term of office of the delegates and alternates runs from the end of the 2024 General Assembly meeting until the end of the 2027 General Assembly meeting. Consequently, the first time the delegates newly elected on 14 May 2024 can participate in a General Assembly meeting in their capacity as delegates will be the 2025 General Assembly meeting. However, they may attend the meetings of the full members on 15 and 16 May 2024 as guests. You will receive more information about this once you have submitted your declaration to stand as a candidate for the election of delegates.
