

**Important information about the distributions dated 1 June & 1 July 2023:  
Changes due to new IT system have caused the incorrect display of the detailed statements**

Dear member,

we recently informed you that we used a new, technologically advanced IT system to carry out the [distributions dated 1 June and 1 July 2023](#). This changeover has been a great success for GEMA. However, at present the detailed statements for the categories dealing with performing and broadcasting rights are still being displayed incorrectly in some places.

First of all, we would like to apologise for the inconvenience caused. We are working flat out to rectify these display errors for future distributions. It is important to note that only the actual display of the data has been affected. All royalties have been calculated correctly.

**The display errors are as follows:**

**1. Sub-account incorrect, missing or listed as “0” in detailed statement**

- In categories FS, FS VR, T FS, T FS VR, R, R VR, T, BM, DK, DK VR, E, ED, EM, M, U, UD

In the detailed statements for publishers, both in **GEMA Download** and in the **Online Portal**, the “**Sub-account**” field (UKTO) is in some cases empty or filled in either incorrectly or with a “0” (zero). We expect to be able to make the correct sub-accounts available over the coming weeks.

**2. Category and statement number missing**

- In categories T, T FS, T FS VR

In the individual statements (EA) for categories T FS and T FS VR in **GEMA Download**, the “Category” and “Statement number” columns are empty in cases where there has been a supplement for unallocated royalties (= work number 9999999999). The covering letter also does not show the category for these amounts. In category T, the statement number is not displayed.

### 3. Incorrect display of capping factor

➤ In categories R, FS, T FS (advertising)

The capping factor (FAKT) is displayed incorrectly in a few instances, although the actual calculation was carried out correctly.

### 4. Incorrect duration of musical portion (MT-Dauer) in the usage lists

➤ In category T FS

In the usage lists in **GEMA Download**, a false value is sometimes shown in the “Duration of musical portion” field. Specifically, in some cases the total of the individual usages is displayed instead of the duration of the musical portion.
