These are compensations in the categories GOP and GOP VR (Streaming Mixed Online-Platforms) made for collections from YouTube and Facebook Instagram lacking (usable) usage-reports. These collections can be allocated for YouTube and Facebook Instagram to paneuropean areas of use in 2019. Pursuant to Art. 182e distribution plan, the distribution shall be carried out to rights holders as a supplement to the respective annual income for financial year 2019 in separated category-groups "Aufführung & Wiedergabe" (BM, DK, DK VR, E, ED, EM, KI, U, UD), "Hörfunk" (R, R VR), "Fernsehen & Vorführung" (FS, FS VR of 1/10, T, TD, TD VR, T FS, T FS VR, VOD S, VOD S VR), "Vervielfältigung & Verbreitung" (BT VR, PHONO VR), "Online" (KMOD, KMOD VR, MOD D, MOD D VR, MOD S, MOD S VR, WEB, WEB VR) and "Ausland" (A, A VR).

The rounded average percentual supplement amounts to:
