THE APPLICATION FORM – PLEASE NOTE THE FOLLOWING:

- Please don't forget to sign the application form.
- To become a member of GEMA a one-off admission fee is payable. Authors currently pay EUR 90.00 (plus VAT; making EUR 107.10). We charge an annual membership subscription of EUR 50.00 (tax-free)

Reason for Payment: your first name and surname and the keywords "Application for membership".

WHICH DOCUMENTS DO WE NEED?

To process your application we need:

- The filled in and signed application form
- Only for identification: A legible copy of the front and back page of your identity card or passport.

You can black out data we don't need for the identification (e.g. eye color, size, serial number).

The copy will be destructed immediately after the identity verification.

- A copy of the remittance slip confirming payment of the admission fee and membership subscription.

WHAT HAPPENS THEN?

As soon as you have submitted all the necessary documents and paid the admission fee and membership subscription, GEMA will send you the following documents:

- Your membership number
- GEMA-Statutes
- GEMA-distribution plan – which regulates the distribution of income and contains the deadline for the work registration
- Your individual Deed of Assignment in duplicate for you to sign. Please sign and return both copies to GEMA.

WHAT ELSE SHOULD YOU KNOW?

- Kindly submit your application for membership in good time. The notification of your works is only possible after the admission process is completed. You will be informed about the various options for the work notification in further info sheets which you will receive together with the Deed of Assignment.
- Pseudonym
- Authors can give a pseudonym in the application for membership. You also can use the pseudonym for your work notification. The first pseudonym is free. From the second pseudonym on a lump sum of € 40.00 (plus VAT; making € 47.60) is onetime payable to cover the registration costs for each pseudonym. There are no additional costs.
- The protection of your works is granted by the German Copyright Act, without any special formalities such as membership of GEMA or notification of your works to GEMA being necessary. In case of a dispute (e.g. proof of evidence) you can represent your rights for example by a specialist solicitor for copyright and media law. The rules of civil law apply.
