In the case of a GbR (company established under civil law) details of all partners must be entered. If insufficient space is provided on the form, please attach an appendix with these details.

Uses of your works

Membership of GEMA only makes economic sense, when your works have been performed in public, broadcast on radio or television or published by third parties on audio(visual) carriers available on the market on a specified scale during the current calendar year or if such commercial uses are directly imminent. We therefore kindly request you to notify these (and any other) works to GEMA upon completion of the admission procedure. Tax details: Liability to Value Added Tax

As of a total annual revenue of €17,500 from self-employed work, you might be liable to value added tax. If you have any queries about your VAT liability, please contact your tax adviser.

Forwarding of data to the International Directory of Rights Owners

To enable your rights to be administered abroad, GEMA passes on certain data of its members (such as publisher names, names of editions, details of the Deed of Assignment with GEMA, but not the address) to the IPI (Interested Parties Information) International Directory of Rights Owners, which is used worldwide by the music rights societies. Only when they are in possession of these data are foreign creators' societies in a position to unequivocally identify members of GEMA and to license and distribute royalties for uses of their works abroad. If such data are not passed on, GEMA cannot meet its obligations under the Deed of Assignment as the custodian of the rights of its members.

Admission fee and membership fee payment

There is a one-off admission fee to become a GEMA member. Music publishers currently pay €180.00 (plus VAT; equals a total of €214.20).

In addition, an annual membership fee of €100.00 needs to be paid. The first membership fee is due at the time of admission. Subsequent membership fees shall be offset against your income. Should the income level not reach the membership fee level, the applicant commits to pay the difference between their income and the membership fee at the end of the financial year.

You will receive more information about the payment of the total amount of €314.20 together with the Deed of Assignment.

CHECKLIST FOR THE APPLICATION

Please enclose the following documents with the application for membership, which has been duly completed in legible writing and in full:

Copy of a valid publishing agreement where the participation of the publisher in the pay-outs by GEMA has been agreed in accordance with the GEMA distribution plan.

An extract from the Trade Register showing that the corporate object is the operation of a music publishing business or, if the publisher is not entered in the Trade Register, a copy of the business registration of the owner and/or of all shareholders, making it clear that the activity registered is the operation of a music publishing business.
